A Personal Choice Free Tubal Reversal Giveaway Contest Official Contest Rules

1. Eligibility: A Personal Choice Free Tubal Reversal Giveaway Contest is open only to those who submit entries through the A Personal Choice Tubal Reversal website (www.tubal-reversal.net) and who are **18** years of age at the date of entry.

The contest is only open to legal residents of the United States and Canada and is void where prohibited by law. Employees of A Personal Choice (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the contest. The contest is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

5. Prizes: Winners will receive a free surgery. Up to four (4) free surgeries will be offered with each yearly giveaway contest. The free surgery received depends on the contestant's sterilization method.

Free surgeries will only include; 1) tubal ligation reversal valued at \$6,900, 2) Essure reversal or Essure removal valued at \$7,900, or 3) vasectomy reversal valued at \$6,900. The screening laparoscopy procedure is not offered in this contest. Actual appraised value may differ at time of prize award.

The office of A Personal Choice is closed the week of Christmas for the Christmas Holiday. Free Tubal Reversal Giveaway surgeries will be offered each year the week before the Christmas holiday. The consultation appointments will be on the Wednesday the week before Christmas, the surgeries will be on the Thursday the week before Christmas, and the postoperative appointments will be on the Friday the week before Christmas.

If contest winners are unable attend the consultation, surgery, and postoperative appointments on the exact days mentioned above then they will forfeit their free surgery. Alternative dates will not be provided. If A Personal Choice has enough notice runner up winners will be selected to replace those who have forfeited their free surgery.

After notification of winning, winners must adhere to all the surgery policies of A Personal Choice. These policies include, but are not limited to the following:

- 1. Winners must complete the on-line scheduling form and a phone scheduling interview with a member of the A Personal Choice Nursing Staff.
- 2. Winners must return all signed documents after completing their phone scheduling interview with a

- 3. Winners must be determined to be safe surgical candidates for outpatient surgery. Their candidacy will be determined by Dr. Charles Monteith MD and the anesthesia staff of A Personal Choice after winners have completed the on-line scheduling form and the phone scheduling interview with a member of the A Personal Choice Nursing Staff.
- 4. Winners must have a **Body Mass Index (BMI) less than 37 for women and 45 for men** on the day of the surgery consultation.
- 5. Winners must have all appropriate lab testing completed at least thirty (30) days before surgery. Winners cannot be anemic; their hemoglobin must be above 10 mg/dl and their hematocrit must be above 30 mg/dl.
- 6. Winners must arrive on time the day before surgery for surgery consultation, arrive on time the day of surgery, and arrive on time the day after surgery for their postoperative consultation.
- 7. Winners must bring a responsible adult over the age of 18 with them on the day of surgery consultation, day of surgery, and the day of their postoperative evaluation.
- 8. Winners must stay at one of the hotels listed on the website of A Personal Choice. Winners are responsible for the cost of their hotel stay, travel to North Carolina, travel to the office, food and prescription medications.
- 9. Winners will not be allowed to bring children into the facility. Only one (1) responsible adult will be allowed. Winners are not allowed to have any body piercings or artificial nails on the day of surgery. The specifics of the prize shall be solely determined by the A Personal Choice. No cash or other prize substitution will be permitted. The prize is non-transferable.
